## G. SCIO Online Essay

Oxford teaching is designed to help you develop your academic writing. To help us see the strengths and weaknesses of your present academic writing so that we can provide focused guidance on the course, we may ask you to write an essay:

- Applicants who are currently students MUST complete the essay as described below.
- Applicants who are SCIO alumni need not complete the essay.
- Applicants who are neither current students nor alumni may complete the essay or choose to have a short interview with an Oxford tutor instead. The decision to have an interview should be noted in your email when you submit your application.

Please write no more than 200 words on one of the topics listed below. Do not write a full-length essay, but rather tell us how you would go about testing one of the statements below. Tell us what assumptions you might use to make to construct an argument (e.g. 'I shall assume that demand for healthcare is effectively limitless') and what kind of information you would need and how you might get it. Please adopt the tone and language appropriate for an academic essay: write concisely and edit your work carefully. We are not looking for a mastery of the subject but an ability to construct an argument and decide which evidence you would need to do so.

Students enroll in SCIO Online from Oxford from a variety of backgrounds and religious traditions, and bring their different values and insights to the program. - To submit your application, please send an email to [admissions@cccu.org](mailto:admissions@cccu.org) with the subject line '[Your Name] application to SCIO Online' attaching:
  1. Your completed application form
  2. An academic transcript(s) for your highest academic qualification. An unofficial transcript is sufficient. (Non traditional students who are having an interview need not submit a transcript, but if they can readily do so this would be helpful.)

- Applicants are responsible for ensuring that transcripts, Certification Forms, and faculty recommendations are received by this deadline.
- Incomplete applications may not be considered. (SCIO alumni are not required to submit a faculty recommendation as part of this application)
- Applicants will be notified of an admission decision within one week of submitting an application.
- SCIO Online from Oxford costs and scholarships:
  - \$550 per credit hour, each tutorial seminar is worth 3 credit hours (\$1,650 per seminar)
  - Select two tutorial seminars and receive a \$150 Multi-seminar scholarship
  - SCIO alum receive a \$150 discount
  - Apply for the Summer Term by 24 May and receive a \$150 scholarship
  - Apply for the Autumn Term by 31 July and receive a \$150 scholarship
  - Apply for the January Term by 30 November and receive a \$150 scholarship
  - Applicants can receive a maximum of two discounts/scholarships for a maximum of \$300
